3.	Community strategy update (presentation)	
	Sharon Kemp delivered the presentation, and asked the RTP	
	members to consider if the content was broadly on the right	
	track for the new community strategy. The presentation focussed on the 'game changers' for the borough which	
	would deliver tangible change. Sharon confirmed that the	
	would deliver tangible change. Sharon committed that the	1

strategy was on schedule to be published in March 2017. The main points included:

- The town centre regeneration and the Masterplan
- The new higher level skills centre and pathways to employment
- The world class Advanced Manufacturing Park and increased investment in skills and apprenticeships
- Large scale housing development across the borough
- Locality working getting to know our communities and the best way for them to access services
- Building stronger communities
- Child centred borough
- Health and social care (STP)

Sharon asked the group for comments, and whether they had any additional items for inclusion in the strategy. Sharon informed the group that they would also need to consider the place shaping work, how Rotherham will shape its identity in the future and how we will celebrate success. Comments included:

- the list looks comprehensive, encouraging and sound, albeit a huge endeavour to actually achieve
- there has been a change in attitude over the last 12 months to a more positive and proud outlook and we need to build on this
- more clarity needed around 'building stronger communities'
- the document should be more specific about what the challenges are around social cohesion, and we should ask ourselves if the key things have really been debated
- it is important for the document to have an affinity with Rotherham, and to have the correct top five 'game - changers', with other initiatives to underpin these
- how will the 'child-centred borough' initiative cut across the priorities?
- should digital connectivity should be considered as a cross-cutting theme so that Rotherham can be seen as being innovative?
- the NHS is developing a 'one-stop' service so could partners aim for the same consistency of messages across all organisations?
- the document should be more explicit about

<u>Agreed</u>	integrated health and social care, particularly around more care being delivered in the community, with increased emphasis on self-care and signposting • the presentation and marketing method of the strategy needs to be engaging and embody the vision of Rotherham in the future • an underpinning theme of Rotherham moving forward, addressing inequalities, (taking all of Rotherham forward together to create a move equal borough) aspiration and values was suggested • the strategy should recognise that the voluntary sector needs investment and development • the document needs to reflect the localities terminology that partners will be adopting • the locality model gives Rotherham a chance to have a distinctive infrastructure • funders are more supportive of partnership bids, so opportunities to work collaboratively should be encouraged The partnership team <u>agreed</u> to continue to develop the strategy, taking on board the comments above. 4.	 Theme board spotlight: Business Growth Board (including presentation) Steve Roberts and Simeon Leach delivered an update on the work of the Business Growth Board. The main points included: An update on priority projects and bids for SCR funding (three projects approved to move to full business case stage) The BGB has been fully involved in the development of the town centre masterplan. Consultants (White Young Green) have been appointed and work has commenced. Steve requested a presentation to the RTP of the draft report in early in 2017 Steve asked RTP members where possible to encourage employees to utilise the town centre for shopping and events in order to support the regeneration of the town 	Future agenda

Action	 Place shaping work update - consultation has now concluded and the emerging themes and big ideas together with the visuals were presented to a joint meeting the Business Growth Board and CEO Group on the 2nd November. A further update will be presented at the next RTP meeting Man of Steel – Steve asked that members of the RTP consider visiting the exhibition on the sculpture at Clifton Park Museum. In addition Steve asked the RTP to fully support the Man of Steel wherever possible as he believes that the sculpture is a 'transformational project' for Rotherham and will provide a brilliant mechanism for putting Rotherham on the map and creating a positive brand and identity for the town. 5.	Theme board spotlight: Safer Rotherham Partnership Rob Odell and Karen Hanson delivered an update on the work of the Safer Rotherham Partnership. The main points included: • Details of the Child Sexual Exploitation update report • The partnership plan is now available on the website which outlines the six SRP headline priorities • The Police and Crime Commissioner funding commissioning strategy • The establishment of a Performance Board • The Eastwood Deal Rob Odell highlighted community cohesion as an area where more work is needed, particularly in Eastwood. Rob suggested that a large scale cohesion event could be organised which could have positive outcomes. In addition, concerns were raised about increased ASB and street drinkers in the town centre. Rob confirmed that some additional resources for Special Constables within the town centre may become available shortly. Azizzum Akhtar asked that Eastwood should be thought of in a wider sense (not only 7 streets in Eastwood Village). Rob Odell responded that there are issues in other areas too, and with a new focus on neighbourhood policing then there is a need to focus on problem solving when and where the need arises. There are opportunities to roll out the Eastwood model and learnings from it to other areas where relevant. Rob acknowledged the increases in reported crimes, but	RO

	welcomed the increase in reporting and the opportunity to deliver positive outcomes for victims. Rob concluded that further integration of teams in the future from across agencies would result in better	
6.	outcomes. Partnership update	
u.	Carole Haywood introduced the report which provides an update on partnership activity since the launch of the new RTP in September 2015. The report includes highlights from the last 14 months, together with a timeline of events.	
<u>Action</u>	Carole requested that partners to engage with the calendar of events and supply information regarding their individual organisations events a collective picture showing a suite of activities can be collated. Some of this work requires better co-ordination in terms of support to the wider partnership and theme boards so that we have a better understanding of the support offered by the comms leads. Carole suggested that the communications leads could share the task of attending the theme board meetings, and offered to facilitate a meeting of comms leads to discuss a way forward. Lawson Pater suggested a top down approach where strategic leads decide what information is best shared more widely and when – potentially sharing information on an agreed theme (monthly) from different partners.
